 - Mayor Greer reports that we are in progress of repairing the vandalism happening to the pavilion, gazebo and playground. Heard rumors that there are 6-7 kids on bikes riding around town causing problems.

- **APPROVAL OF July 2023 Minutes**
 - A MOTION was made to approve July 2023 Minutes by Scott Beaumont and seconded by Jeremiah Neal, all were in favor.

 - A MOTION was made to approve July 2023 Financial Reports by Scott Beaumont and Seconded by Jeremiah Neal, all were in favor.
- **OPEN PUBLIC COMMENTS:**

- **UNFINISHED BUSINESS:**
 - Coweta County has been working on the list of repairs for the city of Haralson. They have replaced one of the drainage pipes on magnolia, the other is marked where to cut to make repairs.
 - Michelle has sent a thank you to the county
- **New Business**
 - Review new amendment to Animal Control Ordinance for Coweta County and adopt for city of Haralson. – It is recommended by Attorney Ted Meeker to approve.

- A Motion was made by Scott Beaumont to approve the new 023-23 Animal Control Ordinance by Coweta County for the City of Haralson. The motion was seconded by Belinda Wilson, all were in favor.
 - Review filming/movie agreements and fee schedule.
 - See attached packet/information
 - Ted would like to have the packet emailed to him in word format so he can make any necessary changes. We will review at next month's meeting.
 - Consider installing pickle ball courts for the city – Mayor Greer will reach out to his contact to get an estimate. Consider 2 courts in open field behind old school building (behind the septic field). There is enough room for 2 courts. Proposed to have no lights and no fence.
 - New Holland Tractor tires – Tractor is stored at Scott Beaumont's house under a shed, but a couple of the tires are flat. The tractor has never had tires replaced. Scott has a quote from Southern Tire Mart for replacing all 4 tires, and will come to his location for \$3,115.
 - **A motion was made by Belinda Wilson to replace all four tractor tires on the New Holland tractor that the county owns. The motion was seconded by Jeremiah Neal, all were in favor.**
 - Playground repairs – Mayor Greer has a quote from a playground equipment company to repair the damaged portion of the playground for \$10,600. Michelle will contact GIRMA to see about filing with insurance to make all repairs (Playground, Gazebo pickets, and window and light in Pavilion).
 - Jamie Thompson has also confronted a couple of teenagers that she believes have been vandalizing her property on Main Street.
 - Belinda Wilson addressed the issue of abandoned vehicles located behind the deer cooler, she believes it is the Cietuat property. Michelle will check into it and send them a letter on behalf of the city to ask them to clean up the property.
 - Two additional security cameras have come in and Jeremiah Neal plans to install them over the weekend. It was agreed one will be installed to face toward the parking lot at the pavilion and the other will be at the pavilion facing the kitchen area.
